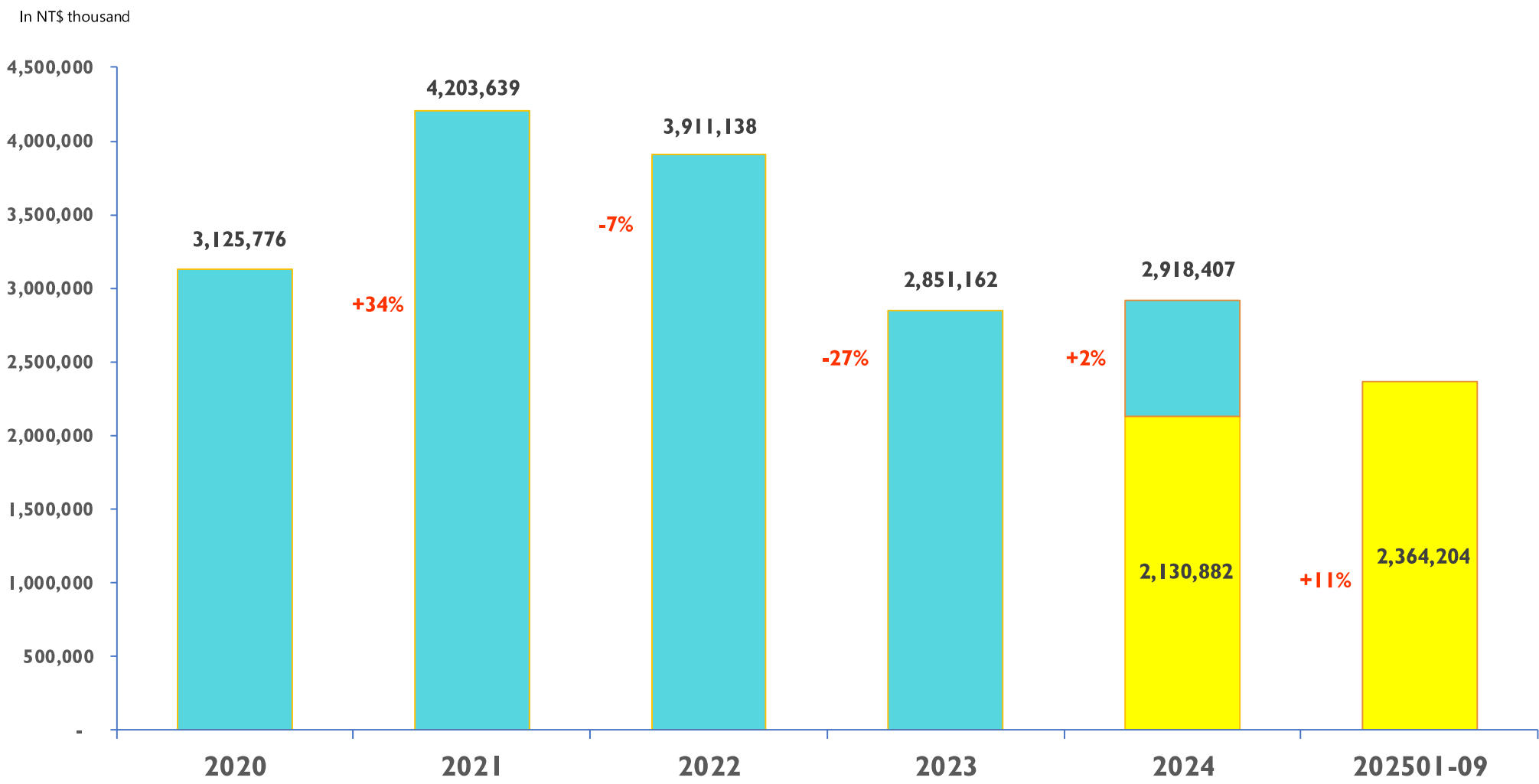

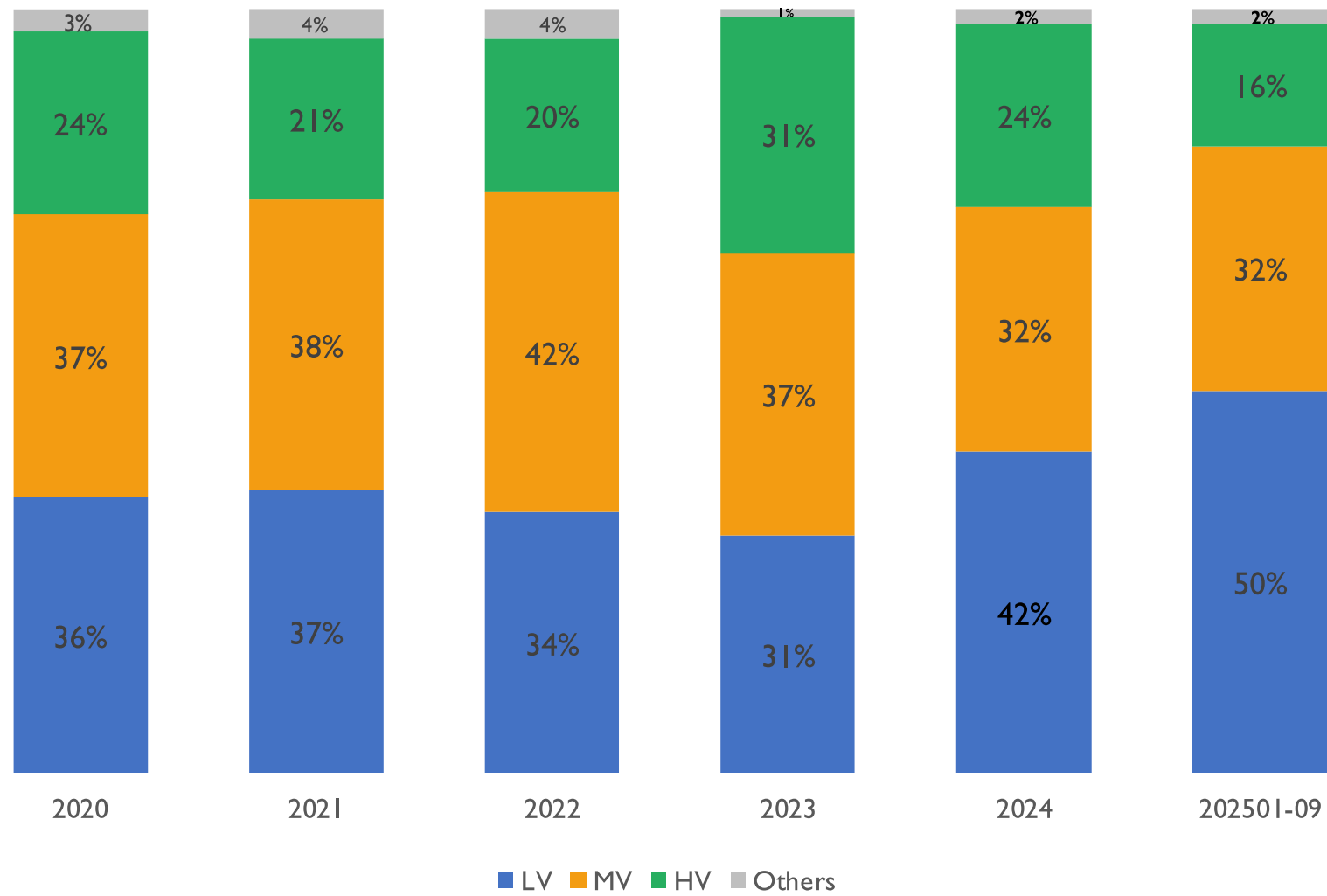

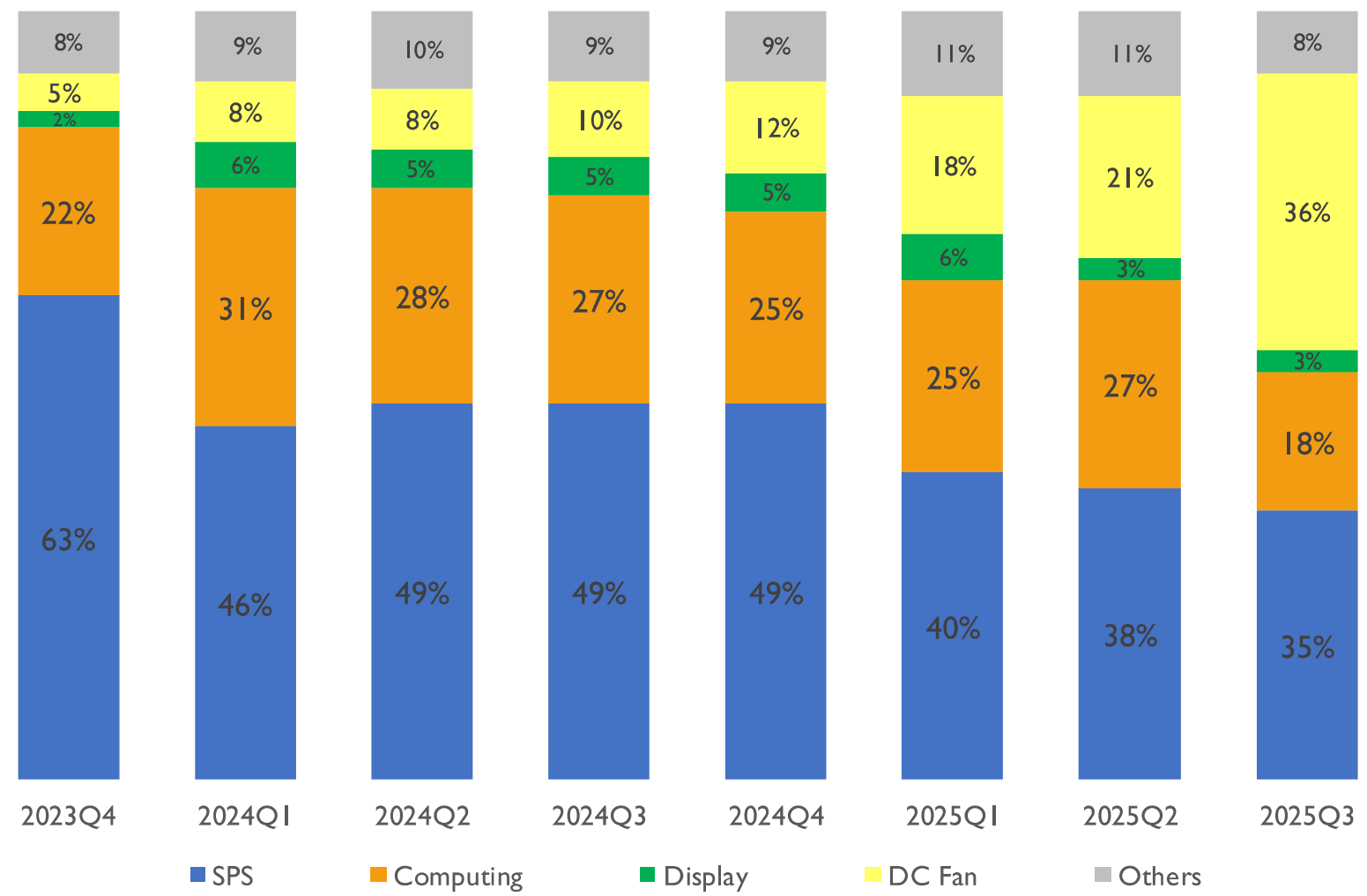
Historical Revenue Summary



Sales Breakdown

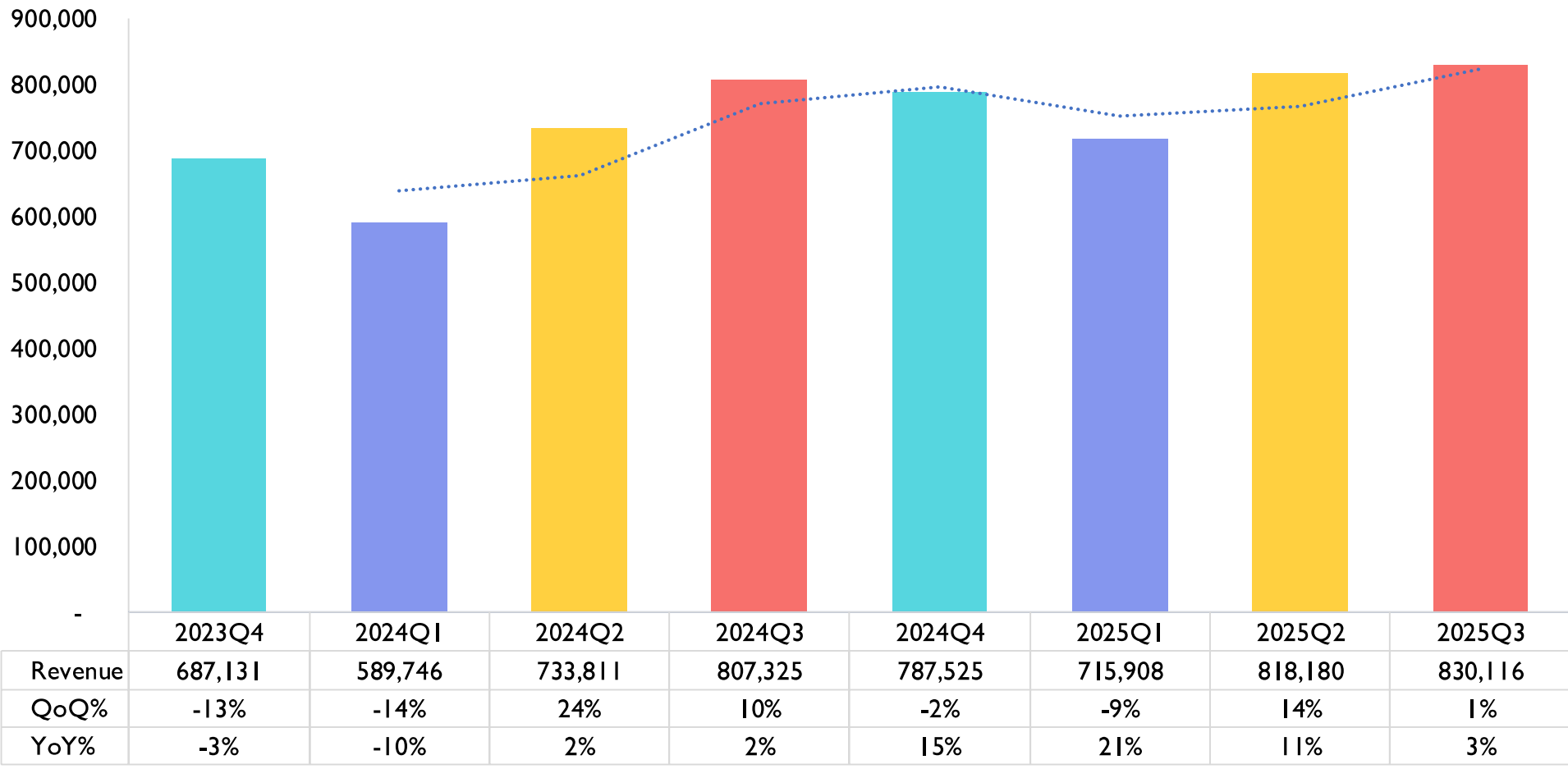


Product Application Breakdown

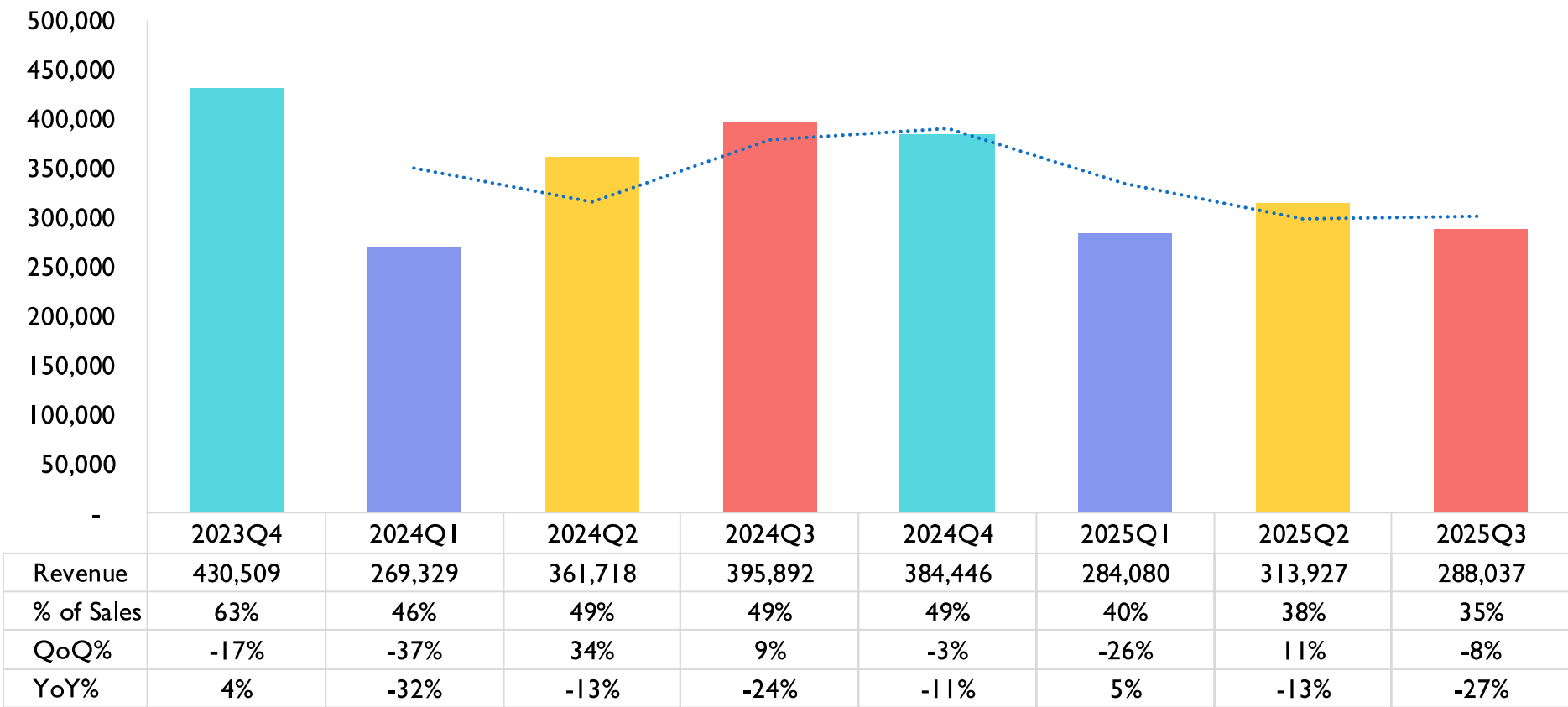




Revenue Summary–By Product Application

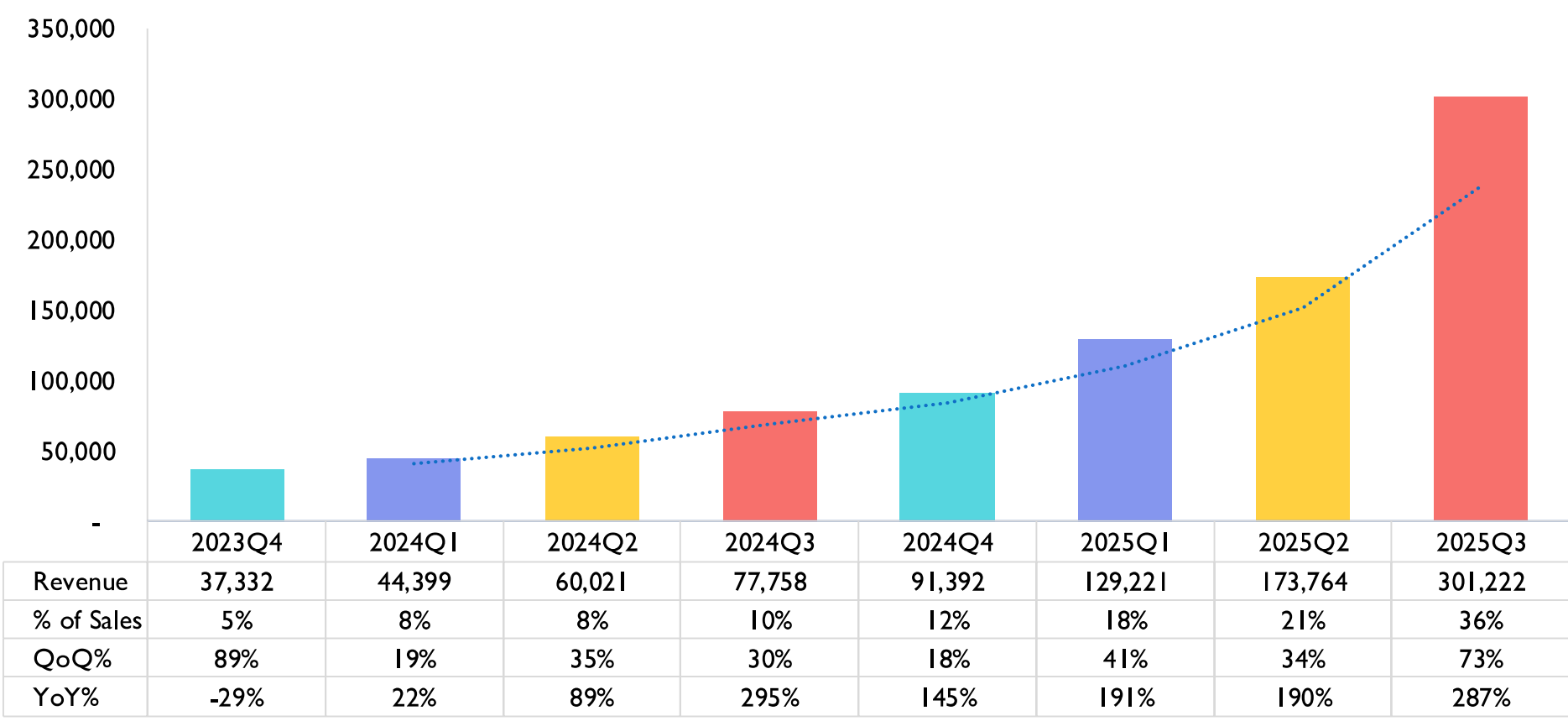

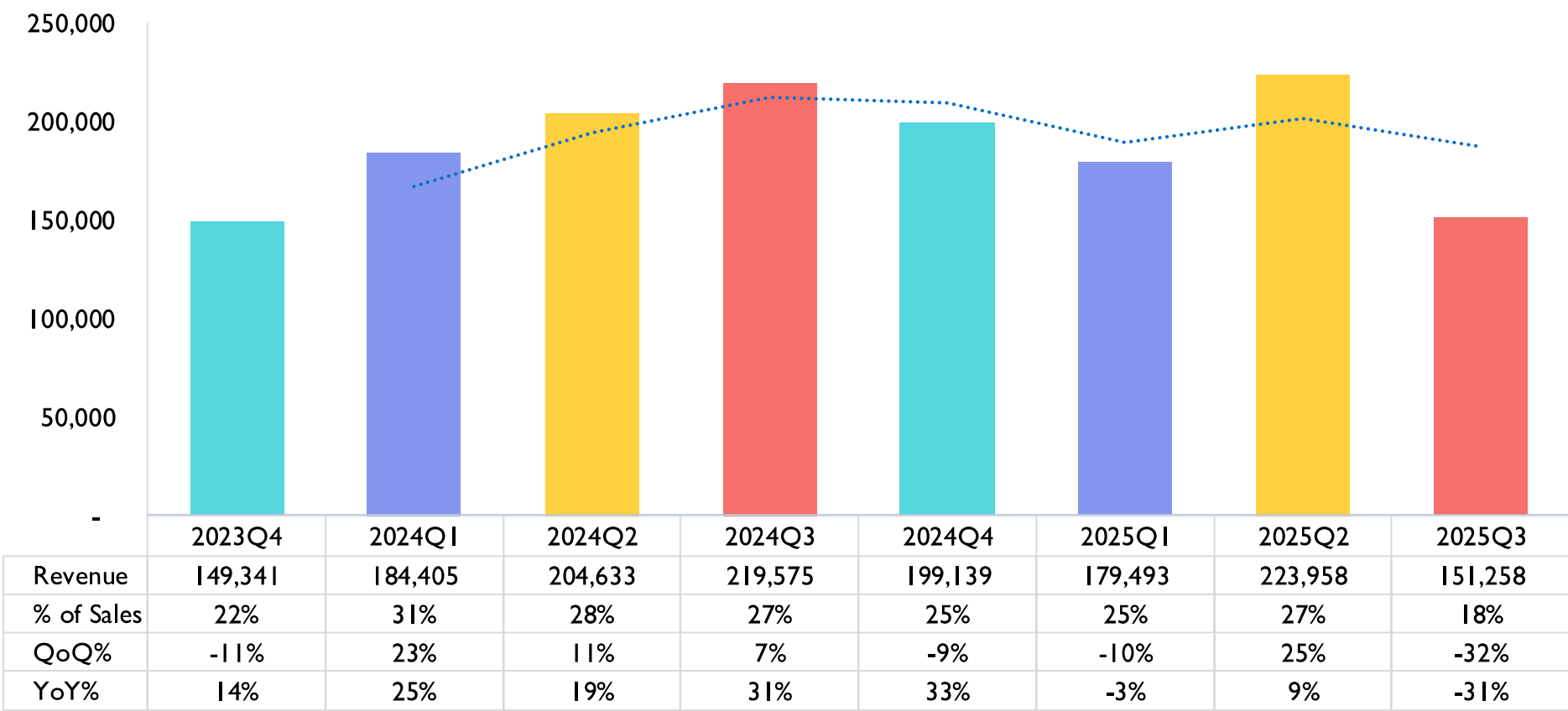
